## Data Protection

The Club will use the information provided on this form, as well as other information it obtains about your child to administer their snowsports activities at this Club and in any other activities in which they participate, to care for and supervise activities in which they are involved. The Club will disclose limited information to Snowsport England, for insurance and administration purposes.

In the event of a medical or child safeguarding issue arising, the Club may disclose certain information to doctors and other medical specialists and/or to police, children's social care, the courts and/or probation offices and potentially, to legal and other advisers involved in an investigation. As the person completing this form, you must ensure each person whose information you include in this form knows what will happen to their information and how it may be disclosed.

## Membership Fees and Subs

- When a new skier comes for an introductory session, we ask you to complete an application form for legal and insurance reasons. We don't ask for membership fees until you decide to join.
- An annual membership is then payable by each member

**Parents or guardians of children under 10** are required to be available at the ski slope for the duration of the session. If your older child is to be left unaccompanied, please ensure that we have access to a telephone number where you can be reached in case of emergency. Many of the parents do stay and watch their children, offering support and encouragement, and meeting with other parents.

**It is essential that all children wear correctly fitted protective helmets whilst skiing.**

## Safe Guarding

- The Club will ensure a duty of care to all members of the club by adopting and implementing the "Snow Safe" Policy, Snowsport England's Policy for Safe-guarding Children, and any future versions of the Policy. This can be [downloaded from the Sharks Website](#).
- We follow Snowsport England's guidance regarding Photography. Parents/children have the right to opt out from the taking of video or photographic images. The photography will focus on the activity/task, not the individual. Please tell us if you have any concerns regarding inappropriate or intrusive photographs.
- All coaches, instructors and helpers have gone through enhanced DBS checks through the national governing body, Snowsport England.

## Codes of Conduct

- Sharks Club Members must adhere to the Club Codes of Conduct for Children, Parents and Carers and Members and Guests, which can be accessed on the [Sharks Website](#).

## Dispute Resolution
